Notice is hereby given of the Steps, Lanes, and Paths ("SLP") Map of the City of Mill Valley. Recordation of this Notice is authorized by Government Code section 27201, subdivision (a), and Mill Valley Municipal Code section 11.36.10. This Notice is exempt from Recording Fees (Govt. Code § 27383) and Filing Fees (Govt. Code § 6103).

The SLP Map was prepared pursuant to Resolution No. 2017-15 of the Mill Valley City Council. The sole purpose of the map is to provide notice to property owners and the public of the general, approximate location of the steps, lanes, and paths listed in the City of Mill Valley's SLP Inventory, which was established by said resolution. The SLP Map neither creates new rights nor affects existing rights related to SLPs or SLP-adjacent properties. The SLP Map is not drawn to scale and was not reviewed or certified by a licensed land surveyor prior to recordation of this Notice.

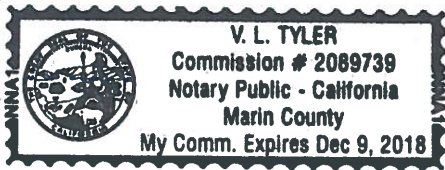
